Joe Austerman gave an update regarding the Matanuska Maid wind down:

- Stated for the month of October a loss of \$51,000 and included in that figure was an allowance for bad debt and real estate taxes which brought the net operating loss down to \$36,000.
- The last day of dairy production will be December 14, 2007.
- The last day of delivery will be December 17, 2007.
- One more load of locally produced milk will be taken on December 17, 2007.
- One last production of eggnog will be December 18, 2007.
- One last delivery will be on December 19, 2007 for Southcentral Alaska.
- Containers will be able to be made for all orders.
- Shelf space is being guaranteed until the end of year.
- Services for the Southcentral Dairy transition can be provided.
- Northern lights Dairy can take the milk for 12/17/07 and possibly accommodate taking milk for 12/19 & 12/23/07 depending on demand.
