be considered on a case by case basis presented to the BAC.

**SECONDED:** Board member Berberich seconded the motion.

Chair VanderWeele asked how to change a no net agriculture land loss similar to how wetlands are handled. Could it be acre for acre?

Director Havemeister stated it would need to be introduced by the legislature.

#### I. BOARD MEMBER COMMENTS:

Board member Flickinger made comments regarding the Chirikof Island cattle issue being discussed by the United States Department of the Interior Fish and Wildlife Service. Board member Flickinger has been to Chirikof Island and the 500 cattle have a good value and could be used as a meat resource if necessary. The habitat damage from the cattle as stated in the articles being distributed is from when the Army was on Chirikof they spilled fuel and left oil drums. The Kodiak Soil & Water Conservation feels the cattle should be allowed to stay on Chirikof Island.

The Board held a discussion.

The Board will send a letter to the US. Fish and Wildlife Service regarding the cattle on Chirikof Island.
