## B. APPROVAL OF AGENDA

**MOTION**: Board member Flickinger moved to approve the agenda.

**SECOND:** Vice Chair Schirack seconded the motion.

**VOTE:** The motion passed without objection.

## PUBLIC COMMENTS/SESSION

Wayne Brost stated in his opinion a Cooperative will not be able to keep Mt. McKinley Meat & Sausage (MMM&S) in operation. The plant needs someone 24 -7 and who has deep pockets to get it to survive. If anyone can make MMM&S continue operations he congratulates them.

Ray Nix stated he worked for the Division of Agriculture for 10 years and hopes the Board takes action that will allow a USDA stamp in Southcentral Alaska.

John Anderson stated he was upset to find out that MMM&S will be turning into a kill floor only effective December 15, 2016 and why wasn't the public notified. This is an insult to all producers that rely on the plant. He spoke to Arthur last week he didn't not deny it. He asked the Board what is their resolution for cut and wrap for re-sale and why hasn't there been any outreach to producers to notify them.

Second, John Anderson asked who will be covering the losses for the plant from December 15, 2016 to June 30, 2017. Unfortunately, many of the documents that he had to review are not current. He asked what the costs versus revenue will be to run the kill floor. In 2015 for six months the utility costs were \$63,000 and he imagines the costs have gone up to \$70,000 or \$75,000 for six months of utilities. If they kill conservatively 650 pigs, 125 beef and 25 mix that would give you a revenue of \$73,025 barely breaking even. Now let's throw in salary for three managers working 40 hours per week from December 15th to June 30th. The new managers are making almost \$25.00 per hour not including benefits and have combined salaries of \$84,000. Where is the revenue and who is going to cover the loss? If the ARLF covers the loss and decides how the plant is going to be run for the next six months, the Division of Agriculture who makes the operating decision's can surely step up to cover the losses.

John Anderson stated that this brings up his next issue he would encourage the Board of Agriculture & Conservation if they decide to award Mike's Meats proposal then set a deadline of March 1st. Greg already has one employee working at MMM&S and the current managers have worked outside with Mike's Meats so a transition would be easy. If you go with the Cooperative he would encourage a penalty past March 1, 2016 which could be a cost share of losses from March 1st to June 30th for example.

John Anderson asked where is the current financial report? Last one was from May and Olga provided a memo claiming it would not be available until September or early October. It is now December and when he asked Lora at the Division of Agriculture where the report is, she said it is still not ready. His question is when will it be ready; it is almost 6 months into the new fiscal year?

Finally, John Anderson stated something needs to be done for people to call back in after the Executive Session. It is unreasonable for the public not to

know what is going on. When the BAC goes into Executive Session, there needs to be a plan in place to notify the public when to call back in to listen for the public session.

Director Keyes:

Stated he has received written notices of resignation from the three employees at Mt. McKinley Meat & Sausage. One employee's last day is December 1, 2016 and the other two employee's last day will be December 15, 2016. Approval was received for three long-term, non-perm employees. One employee is currently working with the two current. Today we received approval for two short-term, non-perm employees and hopefully will have those two employees before December 12, 2016.

Board member Shelden asked if the meat plant would only do the kill floor and not processing. Also on December 15, 2016 will the inmates be going away?

Director Keyes stated he will keep the kill floor open, Hazard Analysis Critical Control Point (HACCP) plan and the USDA stamp. The Division is doing everything it can to staff Mt. McKinley Meat & Sausage as soon as possible. He can't commit to getting rid of the inmates on December 15, 2016.

Natural Resource Manager II Blackburn stated we have the option to hire a Department of Corrections Officer to work at the meat plant if the inmates kept working.

Matanuska Brewing Company would like to request a 60-day extension on the purchase agreement with ARLF which is due to expire December 28<sup>th</sup>, 2016 in order to finalize financing. The bank Matanuska Brewing is going through for financing ordered an appraisal, which is standard lending practice, and the appraisal is scheduled to be completed shortly. Once the appraisal is complete then they just need final approval from the Small Business Administration. Matanuska Brewing Company does not think they will need the full 60 days but the additional time will allow some flexibility with finalizing documents and closing the sale of the property.
