C. PUBLIC COMMENTS/SESSION

Don Brainard representing the Alaska Farmers Union stated the Alaska Farmers Union adopted two resolutions. One in support of Mt. McKinley Meat & Sausage (MMM&S) and the other resolution was for the Seed Potato Program at the Plant Materials Center. The resolutions will be sent to the Governor, Lt. Governor and Legislators.

Deputy Commissioner Fogels stated he has conversations with DOC regarding a path forward. Deputy Commissioner Fogels said that he wants to ensure that there is a USDA meat plant in Southcentral Alaska.

Janet Otto asked why the State doesn't have \$100,000 now but the State can come up with money to move the MMM&S?

Deputy Commissioner Fogels stated a plan that does not need State subsidy at Pt. MacKenzie would be the goal. It would be possible to have the legislature look at a plan. MMM&S has used inmate labor for many years and there are times where we have success with inmate labor and times when inmate labor is not fully available.

Janet Otto stated that the turnover with DOC inmates is what holds the plant back from running at full capacity. Why would they want to move it to Pt. MacKenzie?

Vice Chair Schirack asked what legislators are supporting moving the plant.

Deputy Commissioner Fogels said Representative Neuman supports moving the plant to Pt. MacKenzie.

Board member Shelden stated the agriculture community needs to rise up and submit phone calls and letters in support of MMM&S. The BAC and the Division of Agriculture can't do it on our own. Everyone needs to show support for MMM&S.
