The Agricultural Revolving Loan Fund currently owns Mt. McKinley Meat and Sausage (MMM&S), a slaughter and meat processing facility located at 385 Springer Road in Palmer, Alaska, operated by the Division of Agriculture.

Subject to AS 03.10.050 and regulations implementing this law, the Board of Agriculture and Conservation (BAC) and the Division of Agriculture, are soliciting proposals for the purchase of MMM&S by Request for Proposals (RFP) to persons, firms, partnerships and corporations. The BAC reserves the right to reject any or all offers, postpone or vacate this sale, in whole or in part, at any time, if such action appears necessary to protect the interests of the State. Proposals must be received at the Division of Agriculture Palmer office no later than 3:00 PM, June 9, 2006 to be valid.
