


#### BLM-Alaska Planning Area Map



## Key issues in all of BLM-Alaska's planning efforts

- Alaska Native Claims Settlement Act withdrawals
- Alaska National Interest Lands Conservation Act provisions
- Locatable and leasable minerals
- Travel management
- Subsistence use
- Fish and wildlife habitat management
- Wilderness characteristics
- Wild and scenic rivers
- Special management area designations (such as Areas of Critical Environmental Concern)
- Withdrawals and land status

#### **White Mountains Subunit**

- 1,020,000 acres
- White Mountains Nat'l Recreation Area
- Beaver Creek National Wild River

#### **Steese Subunit**

- 1,275,000 acres
- Steese National Conservation Area
- Birch Creek National Wild River

#### **Upper Black River Subunit**

• 2,361,000 acres

#### **Fortymile Subunit**

- 2,100,000 acres
- Fortymile National Wild & Scenic River

#### **Areas of Critical Environmental Concerns (ACECs)**

#### **Proposed ACECs Under Consideration:**

- Fortymile, White Mountains, and Steese ACECs: Critical caribou calving and post calving habitat, Dall sheep habitat
- Mosquito Flats ACEC: moose calving and swan nesting habitat, unusual floating bog wetland
- Salmon Fork ACEC (Upper Black River subunit): bald eagle nesting, fish habitat, rare plants





#### Looking at a range of management prescriptions for all ACECs

- Some considering recommended closed to mineral entry
- Additional specific prescriptions depending on the ACEC



#### **Central Yukon Planning Issues**


- Central Arctic Management Area
- Dalton Highway Corridor
  - Gas Pipeline Project
  - Ambler Road Project
  - Other projects
  - State of Alaska top filing
  - Sand and gravel availability
  - Invasive species

#### **Partnering Opportunities**

- 15 Tribes (Gov't-to-Gov't Consultation)
- 3 regional corporations
- 12 village corporations
- State of Alaska (Cooperating Agency)
- 2 National Park units
- 7 National Wildlife Refuges (FWS Cooperating Agency)

### **Planning Area -** 16 million acres of BLM-managed land

- 5.3M State selected
- 0.7M Native selected
- 10.0M unselected

## **Planning Area –** 10.6 million acres BLM-managed Land


- 2.6M State selected
- 0.2M Native selected
- 7.8M unselected

- Competition for and access to subsistence resources
- Corridor Desginations:
  - Donlin Mine Pipeline
  - Yukon-to-Kuskokwim Energy Corridor
